IMPERIAL BEACH CHAMBER OF COMMERCE GENERAL BOARD MEETING

Review and Approve June 10, 2015 Minutes:

The minutes of the June 10, 2015 Board meeting were presented for review. After review, Director Odermatt moved the minutes of the June 10, 2015 Board Meeting (attached hereto and made a part hereof) be approved, as presented. This motion was seconded by Director Berry and unanimously carried.

Review and Approve June 30, 2015 Financial Reports:

Director Mickelson presented the June 30, 2015 financial reports for review and approval. After some discussion, Director Baretto moved the financial reports for June 30, 2015 (attached hereto and made a part hereof) be approved as presented. This motion was seconded by Director Pickering and unanimously carried.

Committee Report Updates:

City Liaison Report – Jim Mickelson – Director Mickelson reported that he was not able to attend the City Council meeting but that Ericka Lowery had attended for him. He reported that the city approved the Evergreen and Seacoast proposed development called Lighthouse Point. There was much community discussion which lasted quite a long time. The new assistant city manager, Steve Dush was introduced and gave a brief description of his background. The Sports Park and Boy and Girls Club gave their annual report to the City Council.

Business Improvement District — Christine LaPausky — Director LaPausky was absent. Director Barrows reported there was no B.I.D. meeting this month — which would have been held prior to the Chamber Board meeting. Director Mickelson did report the B.I.D. gave \$2,952.57 to the Imperial Beach Fireworks Fund. The new IB Resort matched funds up to \$9,000.

Monthly Networking breakfast – Director Odermatt reported the next monthly networking breakfast will be held on Thursday, July 23, 2015 and the guest speaker will be Steve Dush (rhymes with Push), the new Assistant City Manager.

BBQ and Blues – Jim Mickelson – Co-chairs of this event are President Osborne and Director Mickelson. The Board was encouraged to help out where they could. This was a huge event last year and will be held in conjunction with the Dempsey Holder Surf Contest. Last year 100% of the beer was donated by the Coronado Brewing Company. We will need to see who will donate this year. We are looking at getting a DJ – Director Berry will talk to Dan.

Ribbon Cuttings - None scheduled as of this date

Sunset Celebrations – B.I.D. – Director Odermatt asked if there were any scheduled Sunset Celebrations this year. In 2014 we had them from June through September. Director LaPausky would be the one to ask that question since the B.I.D. is the one that provides that entertainment. It is believed that a gentleman by the name of Dante (known by Director LaPausky) is currently providing the entertainment on the last Friday of each month.

Executive Committee - Karen Odermatt - Director Odermatt stated there was no outstanding correspondence. She reported that Al Winkleman has expressed an interest to host the next Sundowner. Candy Unger will work on getting this scheduled.

Director Odermatt then asked Director Baretto to report on the current openings on the board. Director Baretto stated that during the last election, there was some incorrect information on the Director Tracker – four board members were showing as active, when in fact, they had resigned – Jerry Bice, Al Winkleman, Jennifer Urbina and Angela Frank. Therefore there are openings for the two individuals that ran for a board position – Mike Simms and William Long. After some discussion, Director Mickelson moved that Mike Simms and William Long be appointed to the Board of Directors of the Imperial Beach Chamber of Commerce for two years to complete remaining terms and balance out the requirement of board tenure. This motion was seconded by Director Landry and unanimously carried.

Mr. Simms and Mr. Long will be contacted and to see if they are still willing to become board members.

Grants:

Director Barrows reported on the current status of grants. The Chamber requested \$40,000 from the County and received \$6,000. A portion of this grant request was for operating expenses. She will try to contact the County to see what we can do in the future to increase our portion of the grant allocation. The current grants we have requested are \$6,000 for the Community Enhancement Grant, \$3,000 from the Tidelands for the BBQ, \$2,000 for Christmas Comes to IB and \$1,000 for the Taste of IB. We need to be aware that when we accept these grants, there is accounting responsibilities that go with these before funds are disbursed. The Committee Chairs need to be sure that all invoices/receipts/requests for payments are in order for auditing purposes.

JPChase Bank/Richard Schaumburg

Director Odermatt distributed a numbered package regarding the JPChase/Richard Schaumburg issue. We are basically at a standstill with the Bank. We are waiting on a response from the DA whether a case will be filed. No one has heard from the Schaumburg's.

By-Laws

The current status of the by-laws were discussed. Director Odermatt would like to move forward with having these reviewed. They should be either approved or offer additional changes. President Osborne would like a line by line review of these by-laws. Director Odermatt stated that is what your committee is for. The Committee has presented the by-laws with proper notification for board review. After some additional discussion, Director Mickelson moved that the by-law review be tabled until the September, 2015 board meeting. This motion was seconded by Director Bachman and carried with Directors Odermatt and Barrows voting no. The motion carried 5-2 with President Osborne not voting.

2015/2016 Strategic Planning Retreat

The 2015/2016 Strategic Planning Retreat meeting was discussed. The Executive Committee recommends that we continue with the same meeting schedule for August, 2015 and plan the retreat for Wednesday, August 12th from 5:00 p.m. and extend the end time to 9:00 p.m. This was agreed to by the Board members present.

Other Business:

Director Mickelson stated the budget had been sent to all directors prior to the meeting. Director Mickelson stated the budget was sent to each director 10 days before the June and July meeting in accordance with our by-laws. After some discussion and review of this budget, Director Mickelson moved that the 2015/2016 Imperial Beach Chamber of Commerce budget be approved, as amended. This motion was seconded by Director Baretto and unanimously carried.

BBQ and Blues

Director Mickelson stated he and President Osborne are co-chairing the BBQ & Blues event to be held on Saturday, September 19th. This will be in conjunction with the Dempsey Holder Surf Competition. If anyone has the time to help, all are welcome.

President Osborne discussed posting of flyers and business cards in the office. There was some discussion on what should be posted — community events, non-profit events, business or individual events. There should be an office policy in place that states flyers may be placed in the back window only and should be dated. Immediately after the event, the flyer should be removed from the window. Should we run out of space, even though this has not been an issue, the oldest flyer will be taken down. No action was taken.

Director Osborne would really like for the Chamber to promote using our website versus flyers in the window.
