## **Review September meeting minutes**

Ms.Barrows asks for a motion to approve minutes. Ms. Paris asks if the BID is a committee or a board. Discussion ensues regarding the structure and procedures to which the BID follows.

Mr. Loudon requests the group introduce themselves.

Mr.Osborne makes a motion to approve the September minutes. Motion seconded by Mr.Hernandez. All in favor motion carried unanimously.

Mr. O'Neal makes a motion to rescind July and August's approval of the financials. Motion seconded by Ms.Parada. Ms.Barrows clarifles that the expense for Sun & Sea be audited and brought back for a vote, depending on the outcome of the audit.
