Minutes of the January 14, 2003 Meeting of the I.B. Chamber of Commerce Board of Directors

In Attendance: David Axelson, Angela Frank, Gene Goycochea, Jr., Donn Hall, John Haupt, Cheryl Jackson, Debbie Janney, Kathy McDaniel, Bill Medlock, Joseph Melluso, Cheryl Schaumburg, Tommie Schuette, Keri Smith and Al Winkleman.

The meeting was called to order at 5:00 pm by Chamber President Cheryl Schaumburg.

The minutes of the November 12, 2002 Board of Directors meeting were reviewed by those in attendance. A motion was made and properly seconded to accept the minutes as distributed. The motion passed unanimously.

Kathy McDaniel of North Island Financial Credit Union spoke about the business symposium that her institution was planning to host Jan. 24. She indicated that representatives from several different banking services would be on hand, who could discuss payroll services, business financing and employment benefit programs among others. McDaniel said that they do handle business accounts and that their rates are very competitive. She said that payroll taxes can be paid through NIFCU.

"What makes us different is that we are big enough to serve you and small enough to know you," McDaniel said. She stressed NIFCU's involvement in the I.B. community.

The discussion turned to the revision of the Chamber's standing committees. The matter was discussed during the November 12, 2002 Board meeting, but action on the concept was tabled until the Jan. 14 meeting.

Axelson suggested a streamlining of the committee structure that the Chamber had used to date, going from 12 standing committees to four. Some discussion followed as to assignments for the 11 event sub-committees, with nominees sought for the Chamber's Barbecue event, which is chaired by Gene Goycochea, Jr.

A motion was made to adopt the committee restructuring as proposed. The motion was properly seconded and passed unanimously. (See attached Chamber Standing Committee list and Event Sub-Committees.)

Axelson reviewed the Chamber event calendar for 2003.

Medlock gave the Board of Directors an overview of the Wine Sampling and Art Festival scheduled for February 13, 2003.

Janney and Melluso combined to present a report on the Business Improvement District's Christmas Comes to I.B. event. Janney indicated that she thought that Melluso and the committee did a great job. Melluso said that he was happy with the results of the first-time event. He indicated that a checklist to improve the event had been prepared and that as an example, roughly three-times more cookies needed to be on hand for the crowd than was available in 2002. Any additional suggestions can be funneled through Axelson for inclusion on the suggestion list.

A collection was taken for flowers to be sent to Art and Jan Zamisch at Balboa Naval Hospital. A total of \$120 was collected and Axelson sent two \$60 floral arrangements the following day to the couple.

Axelson then presented a report on the Chamber's insurance coverage, which he had reviewed. As a result of the review, it was determined that the Chamber did not have workman's compensation insurance and the overall event and office insurance package was overwritten and too expensive. The same insurance for 2002-03 would cost in the neighborhood of \$6,000. Instead the Chamber now has general liability insurance, office and event insurance, directors and officers insurance and workman's comp insurance which will cost \$2683 for 2002-03, a savings of more than \$3,000 for better coverage.

The concept of having each director pay \$40 (times 16 directors for a total of \$640) or roughly half of the premium for the directors and officers insurance was advanced. A motion was made and properly seconded for each director to pay \$40 for the insurance coverage, with Axelson sending an invoice for that amount to each director. The motion passed unanimously.

A motion was then made that when the Chamber became financially solvent and generated a positive cash flow, that the organization would then be responsible for the payment of the directors and officers insurance. The motion was seconded and passed unanimously.

Axelson then presented a complete financial summary of the Chamber from July 1, 2002 through December 31, 2002. Included as part of the summary was a check register for all checks written from the Business Improvement District for the same period of time. A lengthy discussion of the Chamber's financial situation followed, with the sense of the committee being that there wasn't enough funding from either the Chamber or the BID currently to operate separately.

Several thoughts were expressed regarding the financial situation, including:

- Axelson was directed to investigate having a payroll service prepare the Chamber's payroll to keep a better handle on the IRS situation.
- The BID should cover 50 percent of the Chamber's administrative expenses.
- The question of how the BID funds should be spent was discussed.
- The Chamber's current back tax liability was reviewed. The Chamber is waiting for the case to be assigned to a local IRS official for review.
- The concept of a rate membership dues increase for the BID and the Chamber was reviewed.

A motion was made and properly seconded to have the Chamber's Finance Committee meet after the NIFCU Business Expo and the BID brainstorming session, to discuss the payroll service for the Chamber. Also, a mission statement for all three organizations (the Chamber of Commerce, the Visitors' Bureau and the Business Improvement District) should be prepared.

The motion passed unanimously.

Under Old Business, the newsletter concept was discussed. It was decided that a black and white letter-type format would be used due to lack of funds to prepare a printed version with color and pictures.

There was no New Business.

The next meeting of the Board of Directors is scheduled for Tuesday, February 11, 2003 at 5 pm.

The meeting was adjourned at 6:50 pm.
